TSFF5210 is a high speed infrared emitting diode in GaAlAs on GaAlAs double hetero (DH) technology, molded in a clear, untinted plastic package.

DH technology combines high speed with high radiant power at wavelength of 870 nm.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature






Figure 3. Pulse Forward Current vs. Pulse Duration




Figure 6. Relative Radiant Power vs. Wavelength




Figure 4. Forward Current vs. Forward Voltage




Figure 7. Relative Radiant Intensity vs. Angular Displacement




Figure 5. Radiant Intensity vs. Forward Current






Figure 8. Attenuation vs. Frequency
