



DESCRIPTION


These products are miniaturized receivers for infrared remote control systems. A PIN diode and a preamplifier are assembled on a lead frame, the epoxy package acts as an IR filter.

The demodulated output signal can be directly decoded by a microprocessor. The TSOP348.., TSOP322.. are compatible with all common IR remote control data formats. The TSOP324.., TSOP344.. are optimized to suppress almost all spurious pulses from energy saving fluorescent lamps but will also suppress some data signals.






Fig. 1 - Output Active Low




Fig. 2 - Pulse Length and Sensitivity in Dark Ambient




Fig. 3 - Output Function




Fig. 4 - Output Pulse Diagram




Fig. 5 - Frequency Dependence of Responsivity




Fig. 6 - Sensitivity in Bright Ambient




Fig. 7 - Sensitivity vs. Supply Voltage Disturbances




Fig. 8 - Sensitivity vs. Electric Field Disturbances




Fig. 9 - Max. Envelope Duty Cycle vs. Burst Length




Fig. 12 - Horizontal Directivity




Fig. 10 - Sensitivity vs. Ambient Temperature




Fig. 13 - Sensitivity vs. Supply Voltage




Fig. 11 - Relative Spectral Sensitivity vs. Wavelength

SUITABLE DATA FORMAT

These products are designed to suppress spurious output pulses due to noise or disturbance signals. Data and disturbance signals can be distinguished by the devices according to carrier frequency, burst length and envelope duty cycle. The data signal should be close to the band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below.

When a data signal is applied to the IR receiver in the presence of a disturbance signal, the sensitivity of the receiver is reduced to insure that no spurious pulses are present at the output. Some examples of disturbance signals which are suppressed are:

- DC light (e.g. from tungsten bulb or sunlight)
- Continuous signals at any frequency




Fig. 14 - IR Signal from Fluorescent Lamp with Low Modulation




Fig. 15 - IR Signal from Fluorescent Lamp with High Modulation

- Strongly or weakly modulated noise from fluorescent lamps with electronic ballasts (see figure 14 or figure 15)


