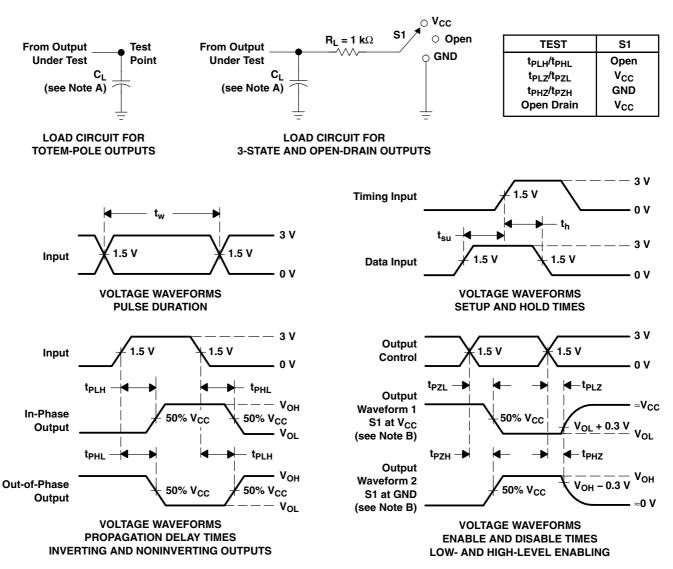

This design optimizes the heat transfer from the integrated circuit (IC).
