






Figure 1. Derating Curve Output Rectified Current




Figure 2. Forward Current Derating Curve




Figure 3. Forward Power Dissipation




Figure 4. Typical Forward Characteristics Per Diode




Figure 5. Typical Reverse Characteristics Per Diode




Figure 6. Typical Junction Capacitance Per Diode








PACKAGE OUTLINE DIMENSIONS in inches (millimeters)




